Motion by Linde to appoint Wendy Stryker as the Township Open Records Officer. Seconded by Cougle and unanimously approved.

Motion by Linde to appoint Elizabeth Lembach as the Township Alternate Open Records Officer. Seconded by Cougle and unanimously approved.

Motion by Linde to approve the 2024 non-union wages with a three percent increase. Seconded by Cougle and unanimously approved.

Motion by Cougle to set the reimbursement rate for employees using personal vehicles for Township business at the 2024 IRS rate of 67 cents per mile. Seconded by Linde and unanimously approved.

Koplin announced the Lehigh County Tax Collection Committee has selected Berkheimer as the Earned Income Tax and Local Service Tax collector for 2024.

Motion by Linde to establish the bond for the Township Treasurer at \$1,500,000 and Township Administrator at \$500,000. Seconded by Cougle and unanimously approved. The Board requested a quote be received for raising the Treasure bond to \$2,000,000

Linde left the meeting at 7:19PM for a personal matter.

Motion by Cougle to establish the 2024 holiday schedule for office closures: January 15, February 19, March 29, May 27, July 4, September 2, November 28, November 29, December 24, December 25, and January 1, 2025. Seconded by Koplin and unanimously approved.

Motion by Cougle to adopt Resolution 2024-1, setting the 2024 Fee Schedule. Seconded by Koplin and unanimously approved.

Motion by Cougle to adopt Resolution 2024-2 authorizing the timely payment of certain expenses. Seconded by Koplin and unanimously approved

Motion by Koplin to adopt Resolution 2024-3, appointing Donna Wright to a five-year term on the Zoning Hearing Board expiring December 31, 2028. Seconded by Cougle and unanimously approved.

Motion by Cougle to adopt Resolution 2024-4 authorizing a cap of \$100 per acre for Lower Milford Township's purchase of agricultural easements within Township boundaries for 2024. Seconded by Koplin and unanimously approved.
