The meeting was convened at 7:33 pm by Chair Wright and the Pledge of Allegiance was recited.

An Executive Session, held after the February 19, 2015 meeting for personnel issues, was announced.

Motion by Roy to approve the minutes of the February 19, 2015 regular meeting, seconded by Wright and unanimously approved.
